## What is the Strategic Plan?

This Strategic Plan outlines the general priorities and direction for Climbing Escalade Canada ("CEC"). It sets out the mission, vision, and values of CEC and serves as the lens through which the Board of Directors, management, and staff look at all decisions.

The Strategic Plan will also act as a tool to help the competitive climbing community hold CEC <u>accountable</u>. CEC will use the Strategic Plan as a <u>benchmark</u> for its annual report, reporting to the community on its progress towards the goals and objectives set out herein.

This iteration of the Strategic Plan is operative for the quadrennial ending with the Los Angeles 2028 Olympic and Paralympic Games.


